2. For the Claims in particular, the following is required
 - a. Letter from the Personnel or Human Resources Director
 - b. After the payment of 25% of Death Benefit. Claims are processed for payment within Ninety (90) days.

FOR MEDICAL CLAIMS:

- A. PERSONNEL OR Human Resources must write and attached all necessary receipts
- B. Receipt and other Documents will be verified by CONTINENTAL GENERAL AND CLAIMS will be settled in one (1) week.
- C. No medical Claims will be settled if found to be fraudulent
- D. All claims are handled through the personnel or the Director or Human Resources.

MOTOR CLAIMS:

- A. YOU MUST FILL IN AN ACCIDENT FORM AND RETURN SAME TO OUR OFFICE
- B. IN THE CASE OF ACCIDENT DO NOT ADMIT LIABILITY
- C. ONLY THE NATIONAL POLICE DECIDE THE CASE OF THE ROAD TRAFFIC ACCIDENT
- D. In case of accident call us on the following numbers, 0886-573-811 or 0886-515-427 or 0886-512-411.
- E. When CONTINENTAL GENERAL takes over the liability, it is the responsibility of CONTINENTAL GENERAL to settle the claims according to the principles of insurance without prejudice.

f. In the case where the vehicle is only covered on a THIRD PARTY basis, we are only concern with damage to the THIRD PARTY, where our client is in the wrong.

g. in the case of comprehensive cover. We settle the Claims less the deductible on the insured Vehicle.

h. You are not wrong until the Traffic Police say so.


