ARTICLES OF INCORPORATION OF ATLANTIC RESOURCES LIMITED

I, the undersigned, for the purpose of organizing a corporation do hereby make, subscribe, and file into the office of the Ministry of Foreign Affairs of the Republic of Liberia, this application for a certificate of Incorporation, pursuant to the Liberia Business Corporation Act of May 19, 1976, as follow:

ARTICLEI

The name of the Corporation (hereinafter referred to as the ("Corporation") shall be "AT! ANTIC RESOURCES LIMITED."

ARTICLE II

The primary objectives and purposes of the Corporation are as follows:

- To engage in the extraction, export and sale of timber, processed timber and timber related products including but not limited to furniture and semi finished timber products;
- 2. To engage in the operation of a saw-mail, plywood, veneer, furniture factories;
- 3. To engage in the provision of contractual and sub-contractual services;
