 - a. Letter from the Personnel or Human Resources Director
 - b. After the Payment of 25% of Death Benefit. Claims are processed for payment within Ninety (90) days.

III FOR MEDICAL CLAIMS:

- a. Personnel or Human Resource Director Must write and attach all necessary receipts
- b. Receipts and other Documents will be verified by CONTINENTAL GENERAL AND CLAIMS will be settled in one (1) week
- c. No medical Claims will be settled if found to be fraudulent
- d. All Claims are handled through the personnel or the Director or Human Resource

IV MOTOR CLAIMS:

- a. You must fill in an accident form and return same to our office
- b. In the case of accident do not admit liability
- c. Only the National Police decide the case of the road traffic accident
