



Demonstrating legality & sustainability 表现出合法性和可持续性

- Forest Products Association of Canada (FPAC)
- 加拿大林产品协会(FPAC)
 - Large corporations (pulp, paper and wood products)
 大型公司(纸浆、纸品和木产品)
 - FPAC committed its membership to achieve SFM certification (CSA, FSC, SFI) on all lands under their management by the end of 2006.
 FPAC已承诺其全体成员公司所管辖的林地至2006年底都获得 SFM认证. (CSA, FSC, SFI)
 - FPAC members are committed to tracing their fibre supplies back to the forest area of origin by the end of 2008 to assure customers that the wood fibre they are using comes from legal sources.

FPAC成员公司承诺到2008年底将会追踪其纤维供应来源直至原森林产地,以确保客户所使用的木纤维来源合法.


Quebec Wood Export Bureau (Q-WEB) 魁北克木材出口协会(Q-WEB)

General Principles – Environment 总则 – 环境

«... committed to sourcing their wood products from companies that can provide evidence that their supply sources are known and legal, and that forests are managed according to legislation in effect. »

«...承诺所采购木产品的供应商能提供证据,证明来源可知及合法,并且森林是依据有效法规在管理.»

« ... members are encouraged to ask their suppliers to sign and abide by the Q-WEB Policy on Wood Origin and Legality » «...鼓励会员们要求他们的供应商签署并遵守魁北克木材出口协会关于木材原产地及合法性的政策规定»

«... independent certification of forests and/or chain of custody tracking systems are excellent tools to ensure that procured wood is from known, legal and well-managed sources that in turn promote sustainable forest management. »

(Guidelines for Verification on Legality and Sustainability of Wood and Wood Products)(木材和木产品合法性及可持续性证明指导方针)

Need for Code of Conduct 需要执行规范 (Already exists for Q-WEB)(Q-WEB已有)

Need for Accreditation and Certificate of Legality 需要合法性鉴定和认证 (In development)(正在制订中)



Working with suppliers → 4 steps approach 与供应商合作 → 4步骤进行

- 1. Inform on the need to sign the Policy (with deadline) and ask for certified products and Chain of Custody 通知对方,需签署政策规定(有最后期限)并要求提供经认证的产品和供应链监管证明
- 2. Follow-ups 进一步跟踪
- 3. Register letter recalling steps 1 & 2 将提醒第一和第二步的信件记录在案
- 4. Removed from preferred suppliers' list or tagged as high risk supplier

Demonstrating origin and legality of wood 证明木材的原产地及合法性

- For North American suppliers (self declaration)
 对于北美地区供应商(自行申报)
 - No need to provide documents of point 5 & 6 of the Policy
 不需要提供规定的第五和第六点所列文件
 - If not confident in one of the suppliers, member will request the appropriate documentation of point 5 & 6 如会员对某一供应商不确信,则需对方提供第五和第六点所需的相应文件

2. International suppliers

- All documents listed in point 5 & 6 of the Policy are requested 应提供规定中第五和第六点所列出的所有文件
- Use of WWF Country Legal Document Lists (Keep it Legal, Appendix 7)
 使用WWF国家法律文件列表 (遵守法律, 附件7)

- Audit of membership once a year by a third party
- 由第三方每年对全体会员进行审计
 - Auditors of CSA, FSC and SFI 来自于CSA, FSC和SFI 的审计人员
- If suppliers have not signed the Policy :
- 如果供应商未曾签署规定
 - Members will have to demonstrate through proper documentation that they followed the 4 steps approach
 - 会员必须提供完整有效的文件记录,证明他们严格遵循了4步骤.
- Q-Web will issue a certificate to members that have met the requirements of the Q-WEB system




Canadian Forest Overview 加拿大森林概况

Basic Facts About Canada's Forests 加拿大森林的基本情况

- 10% of the world's forest is in Canada 拥有世界上10%的森林
 - Forest and other wooded land 401 million ha 森林和其他林地 4.01亿公顷
 - Forest lands 309 million ha 森林覆盖土地 3.09亿公顷
- Roughly 1 million hectares a year is harvested 每年大约采伐100万公顷
- By law, it must be promptly regenerated 法律规定, 被采伐处必须尽快再造林.
 - More than half a billion seedlings are planted each year 每年播种数大于5亿
- Annual allowable cut (2001) 237 Million cubic meters
 每年允许采伐量(2001)为2.37亿立方米
 - Actual harvest (2002) 190 Million cubic meters 实际采伐(2002)为1.9亿立方米
- Forest types:森林种类
 - 22% hardwood(硬木)66% softwood(软木)12% mixed(混合林)
