

Origin

Where do the products come from?

Information accuracy

Is the information about the products credible?

Legality

Have the products been legally produced?

Environmental aspects

Sustainability

Have forests been sustainably managed?

Special places

Have special places, including sensitive ecosystems, been protected?

Climate change

Have climate change issues been addressed?

Environmental protection

Have appropriate environmental controls been applied?

Recycled fiber

Has recycled fiber been used appropriately?

Other resources

Have other resources been used appropriately?

Social aspects

Local communities and indigenous peoples


Have the needs of local communities or indigenous peoples been addressed?
