

Dr. Federico Lopez-Casero is a policy researcher working for the Forest Conservation, Livelihoods and Rights Project at the Institute for Global Environmental Strategies (IGES). IGES is a research institute based in Japan that conducts strategic policy research to support sustainable development in the Asia-Pacific region. The focus of Federico's present work is on exploring policy options to prevent trade in illegal timber, primarily through procurement policies and border control.

Tamara Stark is the forests campaign manager of Greenpeace China. Before coming to China, she had worked with Greenpeace Canada on forests for more than 10 years.

LIU Bing has more than 5 years experience working with international NGOs for the forests issue in China. Now his work with Greenpeace China focus on the forestry political and markets side.

George White has worked for WWF's Global Forest and Trade Network for over 3 years following a career in the retail and timber industries. GFTN is WWF's initiative to engage with the forest industry around the world to promote responsible forest management and responsible purchasing of forest products. Working with over 300 companies in more than 30 countries, GFTN is working directly on tackling illegal logging and related trade issues in all the major production and consumption countries. Today George will give us an overview of GFTN and especially its work in Asian countries.

Xiao Jianmin Ph D. Member of Rainforest Alliance China Program Office. Main fields: feasibility analysis of forest ecology program, forest environmental economics and forest certification.

Mr. Lu Wenming is professor and chief expert on timber trade and forest certification in the Research Institute of Forestry Policy and Information of the Chinese Academy of Forestry. He has been doing research on timber trade for more than two decades and on forest certification for more than one decade. He conducts many international projects on these 2 fields with many international organizations and institutions, such as UNDP, ITTO, FAO, WWF, IGES, EU, CIFOR, IIED, IKEA, FORD etc. He also serves as the Director of the Division of International Cooperation of the Chinese Academy of Forestry.

Ms. Dong Ke is a Forest Program Officer at IUCN China Liaison Office, she served for over five years as Senior Forest Program Officer in the WWF China Program Office, where she was responsible for the WWF/IKEA project, the WWF/World Bank Alliance forest certification project, as well as work on illegal logging, forest governance and sustainable forest management. She also served for 2.5 years in the International Forestry Cooperation Center of the State Forestry Administration (SFA). In her current position, she will be managing forest projects and initiatives in China, in particular the Landscape and Livelihood Initiative (LLS) and the Illegal Logging Dialogues.

Dr Packer is an ecologist by training, spending over a decade in natural resource management

research and teaching in UK and overseas institutions before setting up a UK-based nature conservation charity, followed by an environmental consultancy business, and then moving into industry as a Corporate Responsibility Director. Dr Packer joined GLOBE as Programme Director in September 2006. As well as overseeing GLOBE International's G8 Illegal Logging Dialogue, he is responsible for developing GLOBE's Millennium Ecosystems initiative.

Jade Saunders has been an Associate Fellow of the Energy, Environment and Development Programme at Chatham House (the Royal Institute of International Affairs) in London since 2002. From 2000 to 2002 she was a policy researcher to a Fellow in the programme working on energy, transport and climate change issues.

She now works on natural resource governance, particularly forestry, environmental crime and sustainable finance. Current research includes an on-going exploration of the sustainable development impacts, priorities and responsibilities of public investment, particularly Export Credit Agencies; an analysis of supply chain management in natural resource sectors; new research into the potential for controlling illegal, unreported and unregulated fishing and developing mechanisms for improving transparency in independent resource monitoring. Previous work has included research into the use and effectiveness of various potential border controls against illegally logged timber and work on European timber procurement policies and law; research into the implications and potential for capturing illegal logging profits using the UK Proceeds of Crime Act 2002; research into the potential for restricting current public and private financing of illegal logging and other damaging sectors in tropical forest producing countries.

Cheng Baodong, working in research center of forest product trade belonging to Beijing Forestry University. In recent years, I have been engaged in China's timber trade, and paid much attention to China-Russia timber trade. In 2004, we cooperated with Forest Trends for investigating Russian softwood in China, and accomplished the report "An overview of the Russian Softwood log Commodity and Livelihoods Impacts". Additionally, we cooperated with State Forestry Administration for relative projects, such as "International Competitiveness of China's Timber Industry", "Resource Base of China's Timber Industry", etc.

Duncan Brack is an Associate Fellow of the Energy, Environment and Development Programme at Chatham House (the Royal Institute of International Affairs) in London in the UK. The Programme is one of the world's leading interdisciplinary research centres for a wide range of major international environmental and energy policy issues. From 1998 to 2003, he was Head of the Programme. He now works mainly on international environmental crime, and runs Chatham House's programme of research and meetings on illegal logging and the trade in illegally logged timber.

Yudi Iskandarsyah, working as a deputy manager at TNC Indonesia on a program to promote forest certification and combat illegal logging in Indonesia. The program brings business, government, and environmental and social groups to combat illegal logging and create market links to promote use of wood from well-managed forest. This meeting is very relevant and important for us as an opportunity to share information and experience about our program in Indonesia as well as to learn from others. Hopefully through this meeting there is going to be a

clear understanding on the need for a closer collaboration to improve forest management and combat illegal logging at regional level.
